SCOPE OF WORK

- 1. Filing of Income tax, Goods and Service Tax Returns including revision, if any thereof, advice on GST/Income tax matters, Replies to GST/Income tax authorities on Memorandum/Notices for the Corporation.
- 2. Consultancy related to Compilation of Books of Accounts of all the Branches/Units of the Corporation and preparation of Annual Financial Statements of the Corporation (audited/unaudited as per requirement).
- 3. Assistance in conducting of statutory audit by the Statutory Auditors appointed by the CAG and preparation of reply of statutory auditor's observations.
- 4. Assistance in conducting of AG audit appointed by the CAG and preparation of replies of AG's observations.
- 5. Consultancy related to applicability and charging of TDS/TCS from time to time including Review of quarterly statements in respect of tax deducted/collected before filing return.

- 4. The firms must have Registered Head Office/Branch Office within Union Territory of Jammu and Kashmir (Duly intimated to ICAI).
- 5. The firm should not be blacklisted/debarred from any Department/Board/Corporation etc.

TERMS & CONDITIONS

- 1. The competent authority of JKTDC does not bind itself to accept the lowest or any other tender and reserves to itself to reject any or all the tenders received without assigning any reason. All tenders in which any of the prescribed conditions are not fulfilled or any condition including that of conditional rebate is put forth by the tenderer, the same shall be summarily rejected.
- 2. In financial e-bid, the rates should be quoted in lump sum on per year basis along with applicable taxes as specified in the financial bid Performa.

- 3. The total period of contract is initially for 3 years only but will be awarded on yearly performance basis. The performance of the agency will be reviewed after the end of the every year and if found unsatisfactory, the contract will be terminated without any compensation.
- 4. The committee reserves the right to verify the particulars furnished by the applicant. If at any time, information is found incorrect/ false the e-bid/contract is liable to be cancelled.
- 5. Conditional e-bids shall not be entertained.
- 6. Financial bid shall be considered only those who qualify technical bid in full.
- 7. In-case of date of receiving of e-bids/opening of e-bids, declares/happens to be public holiday, e-bids shall be opened on next working day on the sametime.
- 8. In case of dispute between firm & JKTDC, the matter shall be referred to the sole Arbitrator who shall be Managing Director, JKTDC and the decision of the Arbitrator shall be final and binding on both the parties.
- 9. In case of any dispute, jurisdiction of courts of Union Territory of Jammu and Kashmir isapplicable.
- 10. The preparation of financial statements will be finalized within a period of 5 months from the closing of financial year except for the financial year 2020-21, failing which penalty @ Rs. 200/- per day or 10% of the total value of contract, whichever is less shall be imposed after the completion of time period till the default continues. However, the Managing Director in case of exceptional

- Circumstances may extend the time period and waive the penalty whatsoever, on the justified reasons.
- 11. The earnest money shall be refunded to the unsuccessful ebidders after finalization of the e-bid and earnest money to the successful e-bidder shall be refunded after successful completion of the contract.
- 12. The e-bids which are incomplete, conditional, and telegraphic or received late or without earnest money will not beentertained.
