

4. Bidders who wish to participate in this tender will have to register on line www.jktenders.gov.in. Bidders will have to procure Digital Signature Certificate using which they can sign their electronic bids. Bidders who already have a valid Digital Certificate do not need to procure a new Digital Certificate.
5. The bidders must ensure to upload scanned copy of all necessary documents as specified in the "Technical Bid" in terms of soft copies within period specified above. No documents in terms of hard copies shall be entertained. However, the hard copies of Earnest Money Deposit (CDR) and Tender Document Fee (Demand Draft) should be submitted physically in the office of General Manager Operations Kashmir within the date and time specified above.
