- 1. The agency has to deposit CDR amounting to Rs 40000/- (Rupees Forty thousand only) as Earnest Money pledged to General Manager Operations Kashmir, besides an amount of Rs.1500/- (non-refundable) on account of document charges has to be deposited by the agency in the Corporation Account NO.1237010200000004 and a copy of the deposit receipt has also to be uploaded by the agency with the tender documents.
- 2. The prices shall be quoted by the bidder entirely in Indian rupees. All rates quoted shall not be effected by any escalation in rates, whatsoever and valid for the total period of contract.
- 4. As soon as the acceptance of tender is communicated to the successful tenderer, he/she shall have to execute an agreement with the management of JKTDC within 10 days of the communication of acceptance. The expenses on account of stamps, registration, if any and other incidental charges relating thereto shall have to be borne by the tenderer.

- The service provider whose services have been found poor in the past contract/s with JKTDC or blacklisted by the Govt. or any other organization in the state shall not participate in the tender.
- 6. JKTDC is not any obligation to accept the lowest tender/tenders and reserves the right to reject any or all the tenders without assigning any reason thereof.
- 7. In the event of successful tenderer failing/declining/ neglecting or delaying the supply of Firewood according to the requirement of the Corporation or in the event of any damages caused by his default or failure to comply with the terms and conditions of the contract, the management of JKTDC shall without prejudice to any other remedy available under law for the time being in force in the state.
  - Recover the amount of loss thus caused including the consequential damage as may be determined.
  - ii. Terminate the contract at 07 days notice.
  - iii. Impose penalty up to 10% of the value of contract.
  - iv. Arrange supplies either through re-tender or other wise and the extra cost, if any involved shall be recovered from the contract.
  - v. In case successful tenderer fails to execute supplies as per contractual obligations the EMD deposited shall be forfeited without any further notice.

## 8. Rates, terms and conditions of supply:

- a) The price quoted should be FOR JKTDC T.E Gulmarg/Alambal, T.E Tangmarg, T.E Pahalgam and including dumping the same at the required sites and shall be inclusive of GST, levies and carriage charges etc.
- b) The Supply of Firewood Bhagati duly chopped be supplied and delivered within 03 days positively to the concerned units mentioned in the NIT from the date of issuance of supply order.
- c) The Firewood shall be of pure Bhagati and in case the supply is found other than Bhagati, same shall be rejected and replaced within a reasonable time by the supplier without any extra cost. If due to exigencies of public work/ interest such replacement is not possible, the price of the same will be reduced suitably. The price fixed by the purchaser shall be final.
- d) The quantity of firewood mentioned in the tender notice is tentative however, the same shall be subject to increase or decrease as per actual requirement.
- e) Tender incomplete in any form will be rejected out rightly. Conditional tenders will not be accepted.
- f) The specification and quantity of firewood shall be checked by the concerned unit Manager.

- g) The supply should be made properly weighted and the weighment of each Truck/trolly/Load carrier with load of firewood shall be carried out at any designated weighbridge enroute and in presence of concerned Unit Manager alongwith storekeeper and the supplier, the charges for the same shall be borne by the supplier.
- h) The Unit Manager/Supplier shall share the weighing voucher on the same date with Manager Operations JKTDC Srinagar.
- i) The supplier shall intimate the date of delivery of firewood to the concerned unit Manager before two days in advance.
- j) The contract shall be valid from 15<sup>th</sup> November 2025 TO 30<sup>TH</sup> April 2026.
- k) The successful tenderer shall be required to make the supply of firewood (Bagati) to the respective units of JKTDC against proper requisition and as per their actual requirement from time to time.
- I) The payment shall be made to the contractor after verification and authentication of the bills by the Manager concerned who will also certify that the supply has been made as per the agreement to his best satisfaction.
  - m) 5% of each payment shall be retained as bill deposit which shall be payable after successful /satisfactory completion of the contract. No interest shall be payable by the Corporation as such deposited.
  - n) In case of any difference or dispute with regard to the meaning and interpretation of rates, terms and conditions of this contract, the interpretation and the decision given thereon by the Managing Director JKTDC shall be final and binding on the contractor (the successful tenderer) and the Corporation.
  - o) The contractor shall not assign the above job assignment/ contract to any other party/agency at any stage.
  - p) The contractor has to furnish Income Tax Return of the last three years besides pan card.
